General Terms of Business

Move up – Adrenalin in nature GmbH & Co. KG

1. Every participant must carefully read these stated terms and conditions before entering the Mosel Adventure Forest. By signing this form, the participant acknowledges they fully comprehend all park rules and conditions of use. In the case of underage participants, the legal guardian must read and carefully explain these rules to the minor(s) before the underage participants are allowed to enter the Mosel Adventure Forest. The legal guardian certifies with their signature, to have read, understood and clearly communicated the park rules to the underage participants for whom they are responsible.

2. Participants agree to use of the Mosel Adventure Forest at their own risk. Article 7 governs the liability and responsibility of the Move Up Adrenalin innature GmbH.

3. The high ropes course is open to participants 9 years of age or older (the childrens course for participants age 6 and over), who do not suffer from a mental or physical impairment that could endanger the health and/or safety of themselves or other visitors. Minors under the age of 14 years must be accompanied by an adult. People under the influence of drugs, alcohol, medicines or other intoxicants may not use the high ropes course. Under the direct accompaniment of a legal guardian children under the age of 6 years may possibly be permitted to use the childrens course.

4. While in the high ropes course objects such as openly worn jewelry, mobile telephones, cameras etc. that could potentially present a danger to the participant or for other guests are not permitted. Long hair must be tied with a hair band. Sport clothes and sturdy footwear are also required. Participants with open toed shoes are not allowed to enter any rope course. Dirtying clothes with sap is a likely possibility on the courses, so it is suggested that one wear appropriate clothes. For the dirtying or damage of any clothing articles the Move Up-Adrenalin in Nature GmbH & Co. KG assumes no responsibility/liability.

5. Every participant must take part in the practical and theoretical safety demonstration before entering the high ropes course. All directions and decisions of the person(s) in charge are mandatory. In the case of noncompliance with instructions or breach of safety rules, the infringing participants may be removed from the high ropes course. Move up – Adrenalin in Nature GmbH & Co. KG assumes no responsibility/liability for participants injured due to breach of instructions or safety rules.

6. Equipment rented by the Move up – Adrenalin in Nature GmbH & Co. KG (helmet, belt, safety line with carabineer, steel cable pulley) must be used in accordance with the instructions of the park employees. A participant's rented equipment is not to be used by others, is not allowed to be discarded while in the adventure park, and must be returned at the latest 3 hours after issuance. After 3 hours a price of 5 € per each additional hour will be charged. The safety carabiner must always be put on the red marked safety rope. It is never allowed to have both safety carabiners on the safety rope at the same time. The use of the steel rope pulley must be in exact accordance with the instructions of the park employees. In case of any doubt about proper equipment use, a trained employee is always available to offer assistance.

The Move Up – Adrenalin in Nature GmbH & Co. KG adheres to legal regulations in regards to personal damages/injury. For pecuniary detriment Move Up – Adrenalin in Nature GmbH & Co. KG will only be liable in the case of intentional malice or gross negligence under the direction of the entrusted management.

8. Each station may only be used by one person at a time. On the platform a maximum of 3 people at a time are allowed.

9. The business management reserves the right to remove participants from the park who do not abide by these rules. The management also reserves the right to cease all park operations for safety-related reasons (i.e. fire, rain, thunderstorms). In this case there is no promise of a refund for park entry fees. If the participant wishes to end his/her visit prematurely there will also be no refund of the entry fees.

10. The Move Up – Adrenalin in Nature GmbH & Co. KG reserves the right to take pictures - photos, film or webcam - to use in advertisements or other informational materials.

11. The use of photos, film or webcam material for one's own commercial purposes is strictly forbidden on the entire property of the Move – Up Adrenalin in Nature GmbH & Co. KG. The Move – Up Adrenalin in Nature GmbH & Co. KG reserves the right to claim damages in the case of defiance of this rule.
